15:00 How to navigate supply chain risks and requirements as a non-US DIB contractor How to build a smart, right-sized compliance program

As discussed in recent SOFF webinars and during the other conference sessions, participants in the U.S. (and non-U.S.) Defense Industrial Base are encountering increasing scrutiny from national authorities and prime contractors focused on securing the supply chain, sensitive information (including CMMC and CUI), and critical technology. Effectively addressing these various and complex risks and requirements calls for a deliberate approach. This session will describe strategies for building a right-sized compliance program that deliberately balances risks with resource realities.

In particular, focus will be on:

- Risk assessment and prioritization;
- Leveraging your organization's current compliance program;
- Identifying and prioritizing compliance enhancements;
- Practical strategies to address CUI and CMMC requirements;
- Grappling with scarce resources and stakeholder buy-in;
- Importance of continuous improvement and iteration;
- Integrating program elements with business systems for maximum value; and
- Moving compliance from overhead to value creation.
